St. Paul has a jewel in its midst! For over 30 years, the Ordway has been telling stories that exemplify the human experience. The Ordway believes that the arts belong to us all. As we wind down another year, I would like to reflect on the accomplishments of 2016 and thank an important public figure who is departing from a local office.

2016: St. Paul BOMA was able to accomplish several significant objectives this year.

- Hosted a seminar with Minneapolis Federal Reserve President Neel Kashkari & 150 attendees,
- Organized the inaugural BOMA Benefit Gala for the Community Ambassadors,
- Successfully changed both the Golf Tournament and Expo venues,
- Collaborated with other commercial real estate organizations to offer the 1st MNCRE Day-at-the-Capitol, and

Richard H. Hanson, Senior Vice President at MSP Commercial, a Husband, a Father, and a Friend

As many of you may know, **Rick Hanson** passed away on December 6th after a long battle with cancer. To honor him we are rerunning the Member Spotlight which was featured in the January 2015 newsletter. St. Paul BOMA and the entire membership was fortunate to have Rick, not only as a building and board member, but also as a close friend. He will be deeply missed by all of us.



Where does one start. I suppose at the beginning. I was born and raised in Thief River Falls, Minnesota, where I lived until I was 21. As one of the coldest winter months in the country, finding something to do was a challenge. You can only fish and hunt so much!

The one vivid memory that I have about my childhood was on my 13 birthday (and it was December 13th, and

yes, I am superstitious). I was walking down to the American Legion to see Santa Claus. It was closer to walk across the river, rather than going across the dam, so I choose to walk across the river on the ice. I was about ¾ of the way across and I walked into a soft spot in the ice. I went through and all the way under water. I remember looking up and seeing the bottom of the ice. As luck would have it, the edges of the ice that I had fallen through were thick ice and I managed to pull myself out of the hole. I so wanted to see Santa Claus, so I continued on my way to the American Legend, soaking wet. They called my dad to come and pick me up, but I was still able to get my bag of candy from old St. Nick. The fire department did not see my foot tracks leading away from the hole, so they had already started dragging the river for a body!

After graduating from Lincoln High School, I spent the next five years welding for Arctic Enterprise, welding on front ends and skid frames. One particular Saturday, I was helping a friend change the brake hose in his Pontiac Catalina. We had the front end on a jack, on sand, and the car fell off of the jack. I was pinned underneath the wheel well and broke my back on the lower section. I ended up with a full body brace and was not capable of



holding a job. With nothing else to do with my time, I decided to go to the Pennington County Vocational Technical Institute, where I studied and certified in refrigeration and air conditioning and took the exam for low pressure steam and acquired the state Chief C steam license. At the age of 21, I felt compelled to leave the city of Thief River Falls and moved to Minneapolis, where steam license jobs were plentiful. I worked in building engineering for the next 15 years, until Brookfield Development told me in 1989 to obtain my real estate license, as I was being promoted to Property Manager. At that same time, I

began the process of obtaining my RPA designation through BOMA, completing the courses and final exam and received this designation in 1993. From 1993 until approximately three years ago, I attended monthly membership meetings, but did not experience the full potential of networking through BOMA; I simply attended meetings. About three years ago, I made a decision to become an active member in Greater Saint Paul BOMA by joining a committee and volunteering. This in itself has been very rewarding.



About 15 years ago, I purchase my first of three Harley Davidson motorcycles and, along with a close friend, was able to travel and actually see the greater part of the 48 continental states. This continued until the fall of 2013, with a serious motor cycle accident. At that point, I felt that it was time to stop riding.



I have been married to my wife for 33 years now. Together, we have two adult daughters and eight grandchildren. That in itself takes a lot of time and patience, not to mention the time requirement of owning two dogs, a Yorkshire terrier named Junie, which is my dog (alright guys, I'm proud of it) and a cocker spaniel named Jesse, which is partial to my wife, even though I am required to walk it every night.

District Energy St. Paul purchased the Building historic Jemne from Wold Architects in 2015 and remodeled for occupancy in December 2015. It was built in 1931 and the exterior of the building is on the National Historic Register. The building amazing history, initially has an commissioned for the Women's City Club, it has served as a civic institution, restaurant, theater, museum, and most recently the home to Wold Architects (the previous tenant).



The four-story building is now the home office for District Energy St. Paul and its affiliate, Ever-Green Energy. The building still features some of its more prominent historic features, including the theater and stage (now conference and training rooms), original lighting fixtures (now featuring LEDs), and beautiful tile, wood flooring, and gold-leaf wall treatment. To update the building, District Energy has made energy efficiency improvements, added electric vehicle car charging stations, and instituted a recycling and organics program.

Government Affairs Update

Here is an update on recent government affairs activities by Greater Saint Paul BOMA.

ADA Drive-By Lawsuits

For the past two years, Greater Saint Paul BOMA has worked on the issue of ADA Drive-By Lawsuits. This is a situation where an unscrupulous attorney takes legal action against a property or business for questionable accessibility violations of the Americans with Disabilities Act. Frequently, the notice of the impending action to the defendant is accompanied by a request for payment to the plaintiff to stop the lawsuit.



Saint Paul BOMA worked with other groups during the last legislative session to find relief for businesses from these abusive lawsuits. While a bill was passed, it was watered down by opponents and lacks the protections necessary to curb these lawsuits. BOMA International is also working on a national basis to address this issue.

Businesses in the East Metro haven't seen as many of these lawsuits, but this could change at any moment, so it's

important that we seek legislation to protect properties and businesses. St. Paul BOMA will again work with the State Chamber and other business groups to pass a more comprehensive bill to stop this abuse.

Legislative Update by Sonnie Elliot with Faegre BD Consulting



The 2017 legislative session will convene on January 3^{rd} . The legislature will be setting the budget for the state this session. The Minnesota Constitutional deadline for adjournment is May 22^{nd} .

For the past two legislative sessions, Greater Saint Paul BOMA has worked with our partners in the commercial real estate community to pass business property tax reform. Unfortunately, an omnibus tax bill that had these changes, has failed to become law in the last two years. We will

continue our strong advocacy of a balanced approach to business property tax reductions this session.

BOMA will also be working to put a stop to "drive by" lawsuits brought under the ADA and the MN Human Rights Act. Certain lawyers are bringing "nuisance" lawsuits seeking settlements from businesses instead of going through costly litigation. BOMA followed this issue closely last year. Legislation to remedy this situation was passed and became law during the 2016 legislative session. However, further refinement of the law is needed and BOMA will be working with our partners in the business community to address these changes.

Now that the House and Senate are controlled by one party, there are renewed hopes for compromise. However, any legislation must be signed by DFL Governor Mark Dayton in order to become law. Although the House and Senate have Republican majorities, they do not have the $2/3^{rd}$ majority needed to override a gubernatorial veto.

If major parts of the budget remain unresolved, there will need to be a special session or the government begins to shut down on July 1.

There are at least two opportunities for members of Great Saint Paul BOMA to get involved during the session. **March 8**, **2017** is the Minnesota Business Day at the Capitol and **April 4**, **2017** is the Minnesota Commercial Real Estate Day at the Capitol. It is important for the business community to have its voice heard.
