The MN State Capitol: Where History and Politics Converge

On May 8th, BOMA members were treated to a presentation by **Paul Mandell** regarding the MN State Capitol renovation project. Paul is the Executive Secretary and Principal Planner with the Capitol Area Architectural and Planning Board. He is also one of the most knowledgeable people in the world when it comes to the history and inner workings of the architectural gem we call our Capitol. The meeting occurred in the basement of the building.



After more than a century of use, the Capitol building had reached a critical deterioration point:

- Crumbling exterior marble and stone,
- Life-safety concerns,
- Antiquated mechanical, electric and plumbing systems,
- Inefficient and cumbersome spaces for the public.



Renovation work began in the fall of 2013 and is expected to top \$300M when complete. This is the first comprehensive preservation of the Capitol building since its original construction in 1905.

After the presentation, BOMA members were given a guided tour, and if you haven't been there recently, put it on

your bucket list. Not only is it the seat of state government, but it exhibits unparalleled

design, beauty and history for any building outside of the East Coast. It truly is a Minnesota landmark and we should be proud of the work that has taken place to preserve this treasure.





Legislative Update by Sonnie Elliot with Faegre BD Consulting



The Legislature adjourned a Special Session early the morning of Friday, May 26, after adopting spending bills, including a transportation finance bill, a tax bill and a bonding bill.

Governor Mark Dayton and Republican legislative leaders spent the final weeks of the Regular Session negotiating the budget. With less than two weeks until adjournment, the Republican legislature had sent an entire budget and a

tax bill to the Governor, which he promptly vetoed.

Following the vetoes, negotiations resumed, and on the final night of the Regular Session, a broad agreement was reached between the Legislature and the Governor regarding the budget. Before adjourning the Regular Session, the legislature sent five budget bills to the Governor: Agriculture, Higher Education, Jobs & Economic Development, Environment and Public Safety. As part of the agreement, the Governor agreed to call a Special Session of the Legislature immediately following the Regular Session to let the legislature finish its work.

The Governor and legislators had outlined a broad agreement to finish the remaining bills and a tax bill during the special session. However, the final details of the bills were determined by the legislature without formal agreement on all details. A broader agreement allows the Governor flexibility regarding how he dispatches the bills the legislature ultimate produces.

It took the legislature several days to pass the remaining bills and adjourn the special session. Governor Dayton has 14 days to sign veto or let the bills passed in the special session become law without his signature. The Governor also has line-item veto authority regarding appropriations in the bills.


On Tuesday the Governor signed the \$648 million tax bill. The bill repeals the annual inflationary increase of the Statewide Business Property Tax. The removal of this automatic inflationary adjustment has been at the top of Greater St. Paul BOMA's legislative agenda. This is a great win for Commercial Real Estate, and BOMA's Government Affairs Committee.
