# The Hillcrest Re-Development and the Impact on the Region

Changes are happening at the former Hillcrest Golf Course. The course, located at 2200 Larpenteur Ave. E., has been a fixture of the northeast neighborhoods of St. Paul for almost 100 years — it first opened in 1921. The St. Paul Pipefitters Union Local 455 purchased the golf course in 2011 for \$4.3 million.

The Saint Paul Port Authority acquired the former Hillcrest Golf Course in June 2019 for \$10 million. Redevelopment of the 112-acre site is contingent upon a comprehensive master plan.

The city of Saint Paul's <u>Department of Planning and Economic</u>

<u>Development (PED)</u> is leading the master planning process and a <u>10-person Community Advisory Committee</u> was selected and planning commenced in October 2019.

Community engagement throughout the process will outline how to build opportunity and community wealth on the redeveloped Hillcrest site – bringing more housing, jobs, and public amenities. The City is currently seeking feedback from the community to establish redevelopment priorities, from which concepts will be developed (alongside technical and policy considerations) for further engagement later in 2020.

# MN Legislative Update With Sonnie Elliot

The Minnesota State Legislature adjourned the 2020 legislative session on May 17<sup>th</sup>. Left on the table to complete are a bonding bill of over \$1 billion and allocation of close to \$667 million in federal COVID-19 aid for local governments.

Traditionally, the legislature focuses on capital investment during the even-numbered years. In January, Governor Walz released a proposed \$2.6 billion bonding bill - \$2 billion in general obligation bonds and approximately \$600 million in other funding sources. The Governor recommended several bonding projects for state agencies that BOMA St. Paul is watching carefully. There are concerns these projects will eventually relocate government offices currently in the downtown area to other locations.

House and Senate leadership's bonding proposals, released in the last weeks of session, were different in size and focus. The House DFL bonding bill invested approximately \$2.5 billion in water infrastructure, higher education, corrections, transit, road and bridge repair, and deferred building maintenance. The Senate Republican proposal invested approximately \$1 billion focused heavily on infrastructure, which about half was dedicated to transportation.

Despite negotiations, the legislature was unable to agree on a bill before the legislature adjourned. Both the House and Senate proposals failed on floor votes. Neither body was able to garner enough minority party support for the 3/5ths majority needed to pass a bonding bill. Most other bills require a simple majority of votes to pass and therefore do not require the support of minority votes for successful passage.

Before the failed votes on the bonding bill were taken, the legislature was aware the Governor would likely be calling them back for special session by June 12, 2020. The purpose of the special session is to allow the Governor to extend his Peace Time Emergency authority established in response to COVID-19. The Governor issued Executive Order 20-01, establishing a peacetime emergency, on March 13, 2020.

Once the special session is called, the legislature controls the agenda and length of the special session. This gives the legislature an opportunity to pass priorities, such as the bonding bill, which were unsuccessful during the regular session. Typically, before declaring a special session, the Governor and legislative leaders agree to a timeline and agenda.

## A Search for Positivity in Property Management

5/11 – The first BOMA membership meeting conducted over Zoom kicked off with new Board Chair **David Ketcham** introducing the keynote speaker **Adele Bayless**, RPA, FMA, Senior General Manager in Commercial Real Estate. He welcomed the two new board members, **Bill Huepenbecker** of Xcel Energy Center and **Jordan Roberdeau** of Creative Lawn & Landscaping while wishing a fond farewell to departing board members **Mike Soukup** and **Julie Bauch**. David also took a moment to thank Jerry Hersman, the immediate past chair, for all the work he put into the Greater Saint Paul BOMA chapter and for "building a better BOMA."



After a nod to premium sponsor District Energy and announcing the 33<sup>rd</sup> Annual Golf Tournament, he presented the winners of the Chair's and Volunteer's Awards to **Simon May** of McCaren Designs and **Jean Krueger** of Ramsey County. While it is difficult to properly announce the winners on a digital platform, the recipients of these awards will be honored again at the next opportunity to host a physical event.

David then turned it over to **Sonnie Elliott** of Faegre Drinker to present the legislative update and after that, it was on to the main event.

Adele jumps right to the point of her presentation, asking property managers "Why are you here?" She goes on to describe property managers as *problem managers* – tackling the issues of tenants, service partners, city ordinances and more. And with the pandemic ongoing, these issues create a unique kind of stress. "This is a challenging time," Adele says. "And what is COVID-19, but a huge problem?"

Referencing the book <u>The Four Agreements by Don Miguel Ruiz</u>, she leverages the idea that many of the concepts found within the book can be transmuted into useful advice for property managers - such as taking nothing personally and being impeccable with your word: to speak kindly and positively about yourself and about others. Make no assumptions, is another point Adele presents. Always do your best is the last concept from the book that she touches on, a reminder that our best can look different from day to day and even moment to moment.

She also briefly mentions "building personality" and explains that a building's personality or design reflects on how tenants will expect a property manager to communicate. Are you communicating via formal emails or social media blasts? Will there be cleaning teams or are employees expected to sanitize their own spaces? These are questions to consider when communicating, she says.

The meeting wrapped up with a short Q & A and a reminder to continue to support BOMA service partners. A huge thank you to everyone who signed up and attended – please make sure to register for June's membership meeting as well.


