# MN Legislative Update With Sonnie Elliott

On January 5, 2021 the Minnesota Legislature will commence the 92<sup>nd</sup> legislative session. The most important issue of the upcoming session will be establishing a budget for the state by July 1, 2021 for the biennium FY2022-23. During odd numbered years, the legislature is required to pass a balanced budget for the upcoming biennium. There is a projected deficit of \$1.3 billion for those years.

The November forecast projected a \$635 million budget surplus for the remainder of FY 2020-21 biennium. Of that surplus, \$241 million was appropriated during the last special session, on Monday, December 14th as a COVID relief package.

Governor Walz must release a proposed budget to the legislature by January 26<sup>th</sup>, 2021. This will provide context for both the House and Senate in developing their budgets.


Both the House and Senate have been energized by the improved fall budget forecast. They differ on approach to addressing the budgetary issues that remain. The House DFL majority has indicated helping those most affected by COVID19 as a priority and potential tax increases to address the deficit. The GOP have indicated tax increases are off the table. They prefer tax relief and reopening businesses to spur the economy.

The legislature must adjourn by May 17, 2021. It is hopeful they find an agreement and pass a new budget for the State of Minnesota within that timeframe. If they are unable to find compromise and pass a budget by then, Minnesota would be forced into a special session or risk a government shutdown starting July 1<sup>st</sup>.









# 50<sup>th</sup> Anniversary Celebration

Greater Saint Paul BOMA is excited to be celebrating its 50<sup>th</sup> Anniversary during 2021. As part of this celebration, we'll be visiting with Bill Buth, BOMA's original President, and noted historian of the organization's lore. Joe Spartz caught up with Bill in December.

**Spartz:** Hey Bill. Thanks for taking the time to share with me your memories of St. Paul BOMA. I want to talk with you for a few minutes about the very early years of the association. St. Paul BOMA was founded in 1971. When did you start working with the organization?

**Buth:** I started with St. Paul BOMA in 1974. For the first few years, they had a part time person running the association. In 1974, the BOMA Board felt it was time to hire a full time Executive Director.

Spartz: How did that process work?

**Buth:** The hiring process was run by Gene Rancone, board member and owner of the Northern Federal Building, circa 1973, which was eventually renamed, Ecolab University. While I didn't have commercial real estate experience, the board had faith that I could get the job done, so he hired me. I had no job description and a sparse office in Rancone's new building. I had a desk, a chair, a typewriter and phone, and that was it.

**Spartz:** Do you know what was the motivation to establish St. Paul BOMA in 1971?

**Buth:** Downtown St. Paul was changing, and commercial building owners weren't being heard. They needed a voice. Buildings felt that by creating a BOMA affiliate in St. Paul, this would help them to have an advocate for their interests.

Spartz: What did the membership look like in those early years?

**Buth:** It was all downtown buildings. There were 5 buildings in 1974. The first Service Providers came on in 1985.

Spartz: What were some key accomplishments in the first decade or so?

**Buth:** We had some real solid initiatives. Probably the biggest was helping to create a new energy system in downtown St Paul to replace the N.S.P hot water system. Watt Davidson, owner of the Pioneer Midwest Endicott Building, came to me to encourage BOMA to help make this a reality. BOMA also worked to get SPPD patrolling the skyways. We led the effort to get AEDs installed (Automated External Defibrillator). And we also pushed for skyways to have automated door openers to help disabled individuals.

Watch for more conversations with Bill Buth in upcoming 2021 newsletters as we continue to look back on BOMA's history over the past 50 years.

# **BOMA Reorganizes Committees to Support Goals**



In order to support the new strategic goals that have been approved by the St. Paul BOMA Board of Directors (refer back to Chair's Report), the BOMA office is reorganizing some of the association committees. The Education Committee will become the Membership Committee and will have three primary functions:

# Needlepoint Bipolar Ionization: Making it possible to return to a safe work environment

Having struggled to manage remote workforces for the better part of the year, many businesses, facilities, and building managers are eager to find ways to bring their employees back in both a safe and responsible manner. 
#### What is NPBI ionization and how does it work?



Passing through an ionization field causes harmful compounds to break into one or more of four basic elements: oxygen, nitrogen, carbon dioxide or water vapor.

In addition, the ions kill pathogens by robbing them of life-sustaining hydrogen and breaking down harmful volatile organic compounds, odors, and allergens into harmless compounds such as oxygen  $(O_2)$ , carbon dioxide  $(CO_2)$ , dinitrogen  $(N_2)$ , and water  $(H_2O)$ . The ions then continue to travel within the air stream into more occupied spaces, cleaning the air and surfaces everywhere they go.

#### Is NPBI effective against COVID-19?

In the case of viruses, the ions induce a chemical reaction on the cell membrane surface. In particular, they envelop the COVID-19 virus and puncture the protein spikes on its membrane, effectively neutralizing it in its tracks. Fortunately, this technology is widely available for commercial and public facilities and integrates seamlessly with all HVAC systems. Wider adoption could even help turn the tide against further coronavirus spread. In fact, a leading manufacturer of this technology, <u>Global Plasma Solutions</u> (GPS), conducted independent testing of their technology on the SARS-Cov-2 (COVID-19) virus. They found that after only 30 minutes of use, there was a 99.4% reduction in virus presence, proving that this technology is highly effective in neutralizing Covid-19.

Have you ever watched American Ninja Warrior, or any of the other famous obstacle course shows, and wondered how in the world people are capable of executing such dynamic stunts? Or better yet, have you ever had the fleeting thought that you could become one of the competitors?


Wonder no more because the Treasure Island Center is welcoming a Conquer Ninja Warrior Gym as a new tenant in 2021, which means this may be your opportunity to try out some thrilling obstacle courses, get in better shape, and improve your overall health and fitness! Clients will be able to enjoy open gym, obstacle courses, classes, individual coaching, fitness testing, and more.

I had a chance to speak with one of the individuals behind this endeavor, Ben Utecht, a former NFL player who won Super Bowl XLI as a tight end with the Indianapolis Colts. Utecht is a person of many talents and is often referred to as a "renaissance man". He's a writer, life coach, motivational speaker, singer, and guitar player, just to name a few of his areas of expertise. His speaking program Believe in Culture™ sheds light on how to succeed in business and life. He has written a book, Counting the Days While My Mind Slips

Away which speaks on brain injury. Utecht has been a Dove nominated professional singer and also performed with some of the world's best orchestras and conductors.

Though Utecht has soared to great heights, he has remained humble and cherishes the people he has encountered in life. When I asked him to describe his vision for the gym, he began by emphasizing the importance of relationships. "Everything comes down to relationships. Almost every opportunity that I've ever had has come out of a relationship," Utecht said.

Utecht played for the University of Minnesota and his relationship with NFL Hall of Famer Tony Dungy (a former Minnesota Gopher) helped him transition from college football to the pros.

A solid relationship is what brought about his latest undertaking with the Treasure Island Center. About eight months ago, Lee Krueger, the president of the St. Paul Port Authority reached out to Utecht with an idea for a project. Their discourse and strengthening relationship led to the opportunity for Utecht to open Conquer Ninja Warrior at Treasure Island Center. Utecht's vision with the gym is to serve a missional purpose. He aims to revitalize the community by uniting entrepreneurs and social advocates. The main goal for both Utecht and Krueger is to provide resources and services for the underserved and underrepresented residents of St. Paul. Utecht is also excited to combine social impact with business. Furthermore, his background as an athlete has given him a deep understanding of the powerful life and physical lessons that sports involvement brings.

Utecht's partnership with <u>Finish Line Wellness</u> will greatly enhance the gym through chiropractic, acupuncture, therapeutic exercise, massage, physical therapy, behavioral health services, financial wellness (e.g., educating people on proper budgeting to better take care of their family), and more.

"The Conquer Ninja Warrior gym is this awesome obstacle course that's based off the American Ninja Warrior television show," mentioned Utecht. "It is just so cool. I'm turning 40 this year and even I get giddy!" he added.

I was also able to get in touch with Lee Krueger, whose insight nicely complemented my conversation with Ben Utecht. Krueger outlined several highlights:

- They've combined this project with D1 Training, which has allowed them to fill 20,000 square feet of interior tenant space on a skyway (Treasure Island Center, due to its elevation changes, has two skyway levels).
- Ben Utecht and his partners, fully embraced the concept of a Community Engagement Center.
- Conquer Ninja Warrior will provide a location for Saint Paul's Firefighters to work out and for the Saint Paul Police Department to use as a mechanism to reach young Saint Paul residents within a forum that provides for a safe, friendly environment. Building bridges and restoring trust within the community will be an intended outcome.

#### About the target audience:

"We're looking at a younger, more dispersed customer base," mentioned Krueger. He anticipates customers from all around the metro that will participate in the Conquer Ninja Warrior activities, which will, in turn, attract visitors that can partake in the TRIA Rink activities, the Children's and Science Museums, as well as the many downtown restaurants, and much more. Krueger added that "When we can get visitors to stay in the downtown area for multiple visits and for more than a few hours, it creates the "cross shopping" experience that aids in the downtown experience and vibrancy. We want people to stay and enjoy the city, rather than grab a quick "to go" meal." Krueger knows that by nature, the uniting of Conquer Ninja Warrior with D1 training and Finish Line Wellness, will create a location where customers will come back on a regular basis. "This is what adds to the vitality of the city," he stated. Krueger emphasized that customers are looking for an "experience," and this collaboration provides that opportunity.

So, when should we expect the grand opening to occur, you might ask? While Utecht and all the other key players are aware of the factors that could delay a grand opening (the dreaded "p" word comes to mind, of course), they are pushing for what they hope is a mid-March opening and are in the planning process now, according to Utecht.
