NEXT MEMBER MEETING: HOW WILL CARBON-FREE LEGISLATION IMPACT COMMERCIAL REAL ESTATE? JANUARY 8TH, 2024

During the 2023 Legislative Session, a new law was passed requiring that all electricity generated or procured in Minnesota must come from a carbon-free source by 2040. While the intent of this legislation is to address the climate crisis.

it does raise some concerns for commercial real estate and residents throughout the state.

With over half of current electricity production in Minnesota generated by coal and natural gas, how will these key energy sources be replaced in 17 years? How will the rollout of many new electric vehicles impact total demand for electricity over the next 10 – 20 years? If wind and solar are being targeted as the primary energy sources to replace these fossil fuels, where will Minnesota get its electricity during a polar vortex when neither of these methods can be relied on for significant production? How can new nuclear reactors play a role in meeting the 2040 requirement? Reliable electricity is essential for the operation of commercial real estate and all businesses in Minnesota.

Join us as **Trisha Duncan with Xcel Energy** and **Phillip Hult with Generation Atomic** bring us up to speed. Plan to attend the January St. Paul BOMA membership meeting where they will discuss this legislation and answer these, and other questions, regarding this important topic.

2023: AN EDUCATIONAL YEAR FOR GREATER SAINT PAUL BOMA



PRESIDENT'S REPORT BY TINA GASSMAN

The cornerstones of Greater Saint Paul BOMA are its education, advocacy, and networking. Our monthly membership meetings and seminars allow BOMA members to earn continuing education credits while gaining valuable insights on the latest trends and best practices in building operations and management. This past year, 2023, was no exception.

In January, experts **Stephen Todd and Peter Dahl** shared trends impacting commercial properties, including ESG (Environmental, Social and Governance), the evolution from Municipal Energy Benchmarking ordinances to Minimum Building Performance Standards, understanding decarbonization and electrification in commercial real estate, and the progression toward Net Zero Energy Buildings.

In February, we took a field trip to Woodbury to tour the new Amazon facility and learn about the logistics of building the facility, its mechanisms, and the impact on the local community, job market, and economy.

Our March membership meeting welcomed **Mayor Melvin Carter** to speak about his goals for economic development and his motivation behind the sales tax increase. He stayed to entertain a lively and lengthy question-and-answer period.

In April, we highlighted new developments adapted to new uses, including St. Joseph's Hospital's conversion to a center for community wellness and health equity.

May's membership meeting focused on a panel discussion on the impending legalization of cannabis. Attorneys **Ryan Winkler** and **Jason Tarasek** along with Property Manager **Bryan Larson** helped us gain insights into the new law and what to consider in leasing to a cannabis business in commercial buildings.

That same month, we held a well-received seminar on how property managers can effectively partner with their security partners to support and enhance law enforcement efforts, moderated by **John Bandemer** of the St. Paul DID and **Shane Zahn** with the Minneapolis DID. We heard from both St. Paul Police Chief **Axel Henry** and Minneapolis Police Chief **Brian O'Hara**, plus contract security experts from American Security Corporation and GardaWorld Security Services.

June brought **Rebecca Frenning** and **Erica Larson** of Pope Design Group to discuss Designing for Neurodiversity in the Workplace. They shared real-life examples of lighting, acoustics, materials, furniture, and technology that can help create supportive environments for all employees.

After a summer break, we began "Mapping the Route to a Consistently Clean and Safe Skyway System" in September with the Deputy Mayor **Jaime Tincher**, along with members of the SPPD, DSI, the City Attorney's office and City Councilmember **Rebecca Noecker**. As part of ongoing work within this multiprong collaboration, we discussed potential solutions for a coordinated approach to ensure consistent implementation of private security, maintenance, and cleaning services throughout the skyway system.

As a part of our annual products and services Expo in September, **Matthew Douglas-May** and **Mark Rader** with the Center for Energy and Environment joined us to discuss the benefits of benchmarking, the overview of Saint Paul's Energy Benchmarking Ordinance, and the Benchmarking technical support and learning resources available through the city.

We presented and released our annual Market Report in October. **Joe Spencer**, President of the St. Paul Downtown Alliance, also shared findings and trends from around the nation and how St. Paul fares in comparison. <u>You can view the entirety of the 2023 Market Report here.</u>

In November we brought together a panel of experts who deal directly with St. Paul's unsheltered community. The Homeless Assistance Response Team, or HART, along with the Saint Paul Police Department's Community Outreach and Stabilization (COAST) Unit, and Listening House, a daytime shelter, helped clarify roles of each entity and answered the tough questions surrounding this complicated issue.

And as I hope you saw on the cover of this newsletter, on December 11th, we wrap up the year with our annual First Responders Appreciation Luncheon. We are so lucky to have such a strong relationship with our city's heroes and truly enjoy this opportunity to celebrate them. **Police Chief Axel Henry** and **Fire Chief Butch Inks** will remark on how this unique public/private partnership is necessary for a better and safer Saint Paul.

The private sector can work directly with the SPPD to prevent incidents that lead to violence while strengthening our security mindset and posture. SAINT PAUL POLICE POLICE Service with a Purpose

SPPD SHIELD is a public/private partnership based on information sharing and defending the City against criminal activity.

SPPD SHIELD keeps private sector partners informed of developing situations within the City and around the world, preparations for upcoming events and new intelligence and threat information.

- SPPD Shield website includes weekly reports, videos, and links to over 115 different sources (ex: DHS, FEMA, FBI, US-CERT, etc.), plus various downloadable publications.
- Real time event email alerts
- Intelligence and Analysis Assessments and Bulletins

What SPPD SHIELD asks of the private sector:

SPPD SHIELD is a two-way street; the key to success is for information to flow in two directions. Private sector personnel are well-situated to serve as eyes and ears for the SPPD. We ask your assistance in the fight against violence and criminal activity by reporting suspicious behavior as soon as possible to the local authorities as well as SHIELD. You will be expected to share your open-source intelligence with Shield. This will assist in our efforts to disseminate important information to other members that could benefit from your intel.
