### CHAIR'S REPORT – Heide Kempf-Schwarze



I had the pleasure of spending time with **Henry Chamberlain** and **Manny Moreno** from BOMA International when they were in Minnesota. It was interesting to what other BOMA markets are seeing and affirming to know that many are facing the same challenges as Saint Paul commercial real estate stakeholders are.

One of the greatest obstacles to getting people back into office buildings is the perception that downtowns, or our urban cores, are unsafe. While statistics may tell a different story, perception is the reality that we all must manage to. There continues to be a focus on improving the experience of downtown users: businesses, visitors, and residents: and we want to acknowledge those efforts by many.

In that vein, Greater Saint Paul BOMA has partnered with Minneapolis BOMA on a public safety seminar in May. Joining us will be **Saint Paul Police Chief, Axel Henry,** and **Minneapolis Police Chief, Brian O'Hara** who will share what each city is faced with and the work they are doing, individually and collaboratively, to address increased crime and public perceptions. For the second half of this two-hour program, we will welcome experts from our contract security Service Partners, who will educate property managers on trends they are seeing and how we can leverage new tools to support the efforts of our partners in the public sector and our tenants. #### MN Legislative Update With Sonnie Elliott

The Minnesota Legislature continues its work at a rapid pace. The House, Senate and Governor's office are under one party Democrat control. This makes it easier to pass bills and have the Governor sign them into law. BOMA and our partners in the business community are busy working to stop or amend legislation that would negatively affect the business community and supporting bills that are positive for our members.

Among the bills of concern, this session, was House File 981 which required the installation of adult-size changing facilities on each floor where there was a restroom accessible to the public.. St Paul BOMA raised concerns about the requirement. The bill author changed her bill to give the Department of Labor and Industry ("DOLI") the authority to create rules regarding the adult changing station requirements. This is a compromise because the DOLI will be promulgating rules and BOMA will need to be vigilant about this going forward.

Another bill BOMA opposed would have required commercial properties to obtain an 80% reduction in energy use in the next 13 years. The language was vague and could have been interpreted as requiring fully electrified buildings; thus a prohibition on all gas heating and other appliances. We worked with the author and the bill and it is now acceptable to BOMA and the business community.

Finally, as in previous sessions, implementation of street improvement fees is being discussed. This bill would provide broad authority to municipalities to impose fees on commercial properties to pay for "street improvements." The legislation loosely ties the NEW fee to a project, but there is no benefits test. At this time, BOMA and others have stopped the bill from being heard.

Towards the end of March, the legislature will turn away from new policy ideas to work on the state's two year budget. This budget must be finalized before session adjourns on May 22nd.

#### BOMA and BOMI Reuniting to Create a New Future in Education and Training

"This partnership will enhance our capabilities in education and training for management professionals and related disciplines. I want to thank BOMA Georgia Chief Executive Officer Gabriel Eckert, FASAE, CAE, for all his work this fall that helped bring us together."

#### BOMA and BOMI Reuniting to Create a New Future in Education and Training

The two organizations have signed a letter of intent to achieve shared management and governance structures, pending a due diligence period expected to conclude in early 2023 and be approved by BOMA, BOMI, and the BOMA Foundation. Under the plan, BOMI International will become BOMA International's nonprofit 501(c)(3) arm, combining with the BOMA Foundation.

BOMA International President and Chief Operating Officer Henry Chamberlain, APR, FASAE, CAE, will take on the added duty of BOMI's volunteer president. BOMI's retiring Chief Executive Officer Jeffrey Horn will assist with the transition.

"During the last several years we have come together to create some valuable joint programs, and BOMI's designations have set the standard in the industry for many years," Chamberlain said. "It is incredibly exciting to be coming together now in this powerful way that will both enhance the quality of our offerings and expand our capacity and speed to market as we produce new education and training to meet workforce needs."
